Thank you for your interest in running a Feis in the Continental Europe and Asia region. The applicable Registration Fee must be paid and proof enclosed with your registration form. Please note adjudicators may only adjudicate in our region once a 3 month calendar period.

As of November 2019 a new rule was passed in our region that Feiseanna must include an "RCCEA Feis Fee" of €1 per dancer in their syllabus. This fee will be payable to RCCEA within 28 days of the Feis.

Please email full results (including Grades & Championships) to the Feis Registrar **within 28 days** of the Feis - where appropriate grading up should be marked clearly.

Once your Feis has been registered you will be sent an official Registration Certificate that must be displayed at the Feis.

If you are a new Feis Organiser or would like assistance or feedback on how to run your Feis or to make improvements RCCEA is able to assist with this.

**COVID-19:** Feis organisers will be expected to fully comply with all laws or guidelines set out in the respective location of the Feis. Please ensure you stay up to date with these and where appropriate factor this into your choice of venue and timetable.
